Academic Entry Requirements for 2026 Intake

A copy of the Entry Requirements for the 2026 intake can be found on our [website](#).

The **required ATAR** for applicants for the 2026 intake with **recent secondary education** is **90.00 or equivalent**, inclusive of adjustment factors.

The **required GPA** for applicants applying for the 2026 intake is **5.30** (out of 7) **for all eligible Undergraduate Study** and **4.80 for all eligible Postgraduate Study**.

Please ensure you have reviewed the [full entry requirements](#) and that all prior study complies before submitting your application.

Application Instructions for Domestic Applicants

UAC applications, Online Supplementary Application Forms and Casper Testing are to be completed by application close at 11.59pm AEST Friday 12 September 2025.

Late applications and incomplete applications will NOT be accepted.

Application Process

STAGE 1 – Written Application

- UAC application
- 'Casper' situational judgement test
- Online Supplementary Application Form



STAGE 2 – Interview

- Conducted online via Zoom
- November/December 2025

Stage 1 – Written Application

All 3 of the following steps require completion:

Step 1. Apply through the NSW Universities Admission Centre (UAC)

- Include Bachelor of Veterinary Biology/Bachelor of Veterinary Science as one of your preferences. This applies to all Australian domestic applicants, including current Charles Sturt University students.
- If you are a current Year 12 student in Australia, or are completing an Australian Year 12 qualification overseas, please upload your most recent High School report.
- For all other applicants, please upload details of your most recent studies and all qualifications within the UAC application. This includes any current/incomplete study, including study at Charles Sturt University.

Step 2. Complete your Casper situational judgement assessment

- Please refer [information about the Casper assessment](#) for instructions on how to register and complete the test.
- There will be 4 testing dates available – 22 May 2025, 19 June 2025, 5 August 2025 and 11 September 2025. Please register for your test at least 3 days in advance.
- Please note that scores from the Casper test will be supplied directly to Charles Sturt from Acuity Insights so you do not need to wait for results to submit your application.

Step 3. Complete the online [Supplementary Application Form](#) and upload all supporting documents, as identified on the form. All sections must be completed and submitted by the closing date for this application to be accepted.

The online Supplementary Application Form is accessed through a log in process, and you will have the opportunity to save the form without submitting. Please note that once the form has been submitted there will not be an opportunity to add any further information.

As part of the online supplementary application form you will be asked to provide evidence of work experience, or other leadership experience (relating to formal positions and/or personal leadership and group activities). It is expected that you will have at least three experiences that demonstrate your commitment to veterinary science in regional and rural communities.

- This may include work experience in workplaces/environments, veterinary practices and other veterinary or animal production enterprises, including the family farm, where you have gained experience relevant to your interest in the livestock industries, veterinary science and regional and rural communities.
- Supporting documents are required for each experience and must include:
 - Date and number of days of experience (must have been completed within the past 7 years).
 - Valid identifiers and contact details (e.g. letterhead, ABN, date, name and signature by the owner/manager/supervisor)
 - Pay slips will not be accepted as evidence of experience.

Stage 2 – Interview

Applicants who progress to Stage 2 will be invited to attend an online interview which will be held via Zoom in the last week of November or first week of December 2025 (Please note that attending an interview during this time is compulsory and no other interview times will be offered. Please make sure you are available to connect to a Zoom interview during these times).

Invitations for successful applicants to attend interviews will be sent out via email in early to mid November 2025. Please note that some of these interviews will be conditional on the applicant gaining an eligible academic result where this is not available before this date.

Please ensure that our email address (FOSH-course@csu.edu.au) is included in your list of contacts to avoid our communication being sent to your junk mail and you not receiving correspondence from us.

Stage 3 – Offer

Successful applicants will be advised by letter of offer – first round offers will be via UAC on 23 December 2025, with other rounds of offers in January and February 2026.
