COURSE REQUIREMENTS

Registration with the Psychology Board of Australia

On acceptance into either course, candidates who do not hold registration as a psychologist must apply to the Psychology Board of Australia (PsyBA) for provisional registration. Provisional registration is usually granted for one calendar year and must be maintained throughout your enrolment in the course. https://www.psychologyboard.gov.au/Registration/Provisional.aspx

All successful candidates must at least hold provisional registration. Where the PsyBA refuses an application for provisional registration, or where registration is subsequently cancelled during the program, your enrolment will be withdrawn.

Workplace Learning

The **Master of Clinical Psychology** and **Master of Professional Psychology** require students to complete the requisite placement hours under the supervision of a board approved psychologist.

Due to the diverse geographical locations of our students, and in accordance with established Charles Sturt guidelines, students are responsible for organising their placement. All costs associated with the placement experience are borne by the student, if applicable. This includes where completion of placement requires travel or temporary relocation, or where payment for external supervision is the only option available in a chosen setting.

REFERENCES

Applicants are required to arrange references from a minimum of **three** professional or academic referees, to be submitted online. <u>https://www.psychologyreference.com.au</u>

It is the applicant's responsibility to ensure that references are lodged and are made available to Charles Sturt **by the UAC closing date.** References cannot be submitted in any other format and applications without references by the closing date will not be considered.

TIME COMMITMENT

It is critical that prospective students carefully consider the commitment required to undertake the **Master of Clinical Psychology** and **Master of Professional Psychology** through distance education.

Each coursework subject requires a minimum 150 hours of study, or about 10 hours per week for one semester. All subjects have assessment components with fixed due dates for submission, and extensions are not granted based on work pressure or routine family commitments. In our experience, students who attempt to study while working significant hours per week invariably struggle, often failing subjects or withdraw from the program.

I understand that full-time enrolment requires a commitment of approximately 40 hours per week, and that parttime enrolment requires approximately 20 hours per week. I affirm that I will adjust any employment or personal commitments to ensure that I allocate the requisite time commitment to my studies.

SUCCESSFUL CANDIDATES: ADDITIONAL DOCUMENTATION

If you are undertaking a course with clinical or fieldwork placements you must demonstrate compliance with the following checks and requirements. It is your responsibility to ensure that the correct documentation is obtained prior to commencing clinical/fieldwork placements.

- National Police Check through your State or Territory Police Service or the Australian Federal Police.
- Working With Children Check through the Office of the Children's Guardian.
- NDIS Worker Screening for some clinical/fieldwork placements settings
- Immunisation and vaccination requirements for some clinical/fieldwork placements settings

ASSESSING ACADEMIC ELIGIBILITY

The **Master of Clinical Psychology** and **Master of Professional Psychology** each require a four-year APAC-accredited qualification in psychology (or equivalent) to have been completed within the previous ten (10) years^a with a Weighted Average Mark (WAM) of 75% or higher^b for the 4th-year of study.

To ensure an accurate assessment, we require raw marks (%, or mark out of 100) and subject weighting for each 4th year. subject This includes candidates with an incomplete program at the time of application. Please indicate how you will provide this information by selecting an option from the drop-down menu below.

How will you upload your raw marks to UAC?

Selecting "I cannot provide raw marks" or failing to provide raw marks through one of the above options by the application closing date will result in Charles Sturt calculating an indicative WAM based on the lowest mark within the grade banding, according to Charles Sturt grading conventions.

FREQUENTLY ASKED QUESTIONS

The following information is provided as general guidance to applicants to Master of Clinical Psychology, and Master of Professional Psychology at Charles Sturt University.

For information about the courses, applicants should also review the Charles Sturt University website.

Charles Sturt makes every effort to ensure the accuracy of information provided in this admission guide at the time of publication. Applicants are responsible for determining their eligibility to apply.

Application	
How do I apply?	Please visit <u>Universities Admissions Centre</u> (UAC).
	Applicants must complete all components of the application submission process by the closing date. Incomplete applications, and applications without references or completed supplementary documents will not be assessed.
	Please see the UAC website for more information on the application process and how to attach documents. You will be able to apply for multiple courses, and you will need to indicate your preference from 1 to 6.
When do I apply?	Applications for the Master of Clinical Psychology and Master of Professional Psychology programs can be submitted via UAC between early September and the end of October each year. Please check the UAC page for your year of entry for the exact dates.
	Late applications will not be accepted.
Is there a mid-year intake?	No. There is only one intake per year
Are Commonwealth Supported Places (CSP's) available?	The Master of Clinical Psychology and Master of Professional Psychology programs at Charles Sturt are available only as Commonwealth Supported Places. No other fee options are offered.
Can I apply if I am not an Australian citizen or resident?	No, you must be a citizen or resident of Australia to apply for the Psychology Masters programs at Charles Sturt University as you must be eligible to receive a Commonwealth Supported Place.
I will not have finished 4 th year by the closing date, can I apply?	Yes, you can apply and will be required to supply a transcript showing your studies completed to date.
	Individuals with incomplete studies must refer to the UAC portal for the final date to upload documents, as no additional documentation will be accepted after this deadline.
	The supplementary form must also be completed and uploaded at the time of application, and your references must be available on the closing date.
My transcript does not supply raw marks (out of 100), what do I do?	If: (a) your overall result is not on your transcript, (b) your results are not on your transcript as a mark of 100(%) or (c) your results are only available as a GPA or non-numeric grade:
	You are expected to provide a letter from the university with results for each unit of study in the fourth year, weightings for these units and result out of 100(%). It should then be uploaded with your application via UAC. This includes Charles Sturt University 4 th year current students and graduates.

	If you are unable to supply this letter, or it is not uploaded to UAC with your application, your GPA or non-numeric grade (HD, DI etc.) will be mapped to the lower end of our grade scale for ranking purposes.
	Where a university will only send the information to Charles Sturt directly, it should be emailed to <u>fobjbs-course-admin@csu.edu.au</u> and must include your full name, date of birth and email address per your UAC application.
Why do I need to submit raw marks for my 4 th year?	Different institutions have different grading systems, so it is ideal for final results to be submitted in the format of a (marks) out of 100 to ensure an equitable assessment of results.
	If your institution does not provide raw marks, please request your School or relevant administrative department to provide you with a letter confirming your overall and/or individual subject marks out of 100. This should be uploaded with your application.
How many places are offered in the courses?	Places on postgraduate psychology programs are limited and we typically receive a very high volume of applications.
	Applicants are reminded that failure to receive an invitation to interview, or offer of candidature, does not indicate a determination of lack of suitability for postgraduate professional psychology training but, instead, reflects the high standard of applications Charles Sturt receives each year.
	For reference: 2025 intake 1100+ unique applicants for approx 40 places across both courses.
How will I be assessed?	Only applicants who have provided all required documents by the cut off will be assessed and, if eligible, included in the ranking for an interview.
	Interview selection is based on academic marks, then referee reports.
My 4 th year psychology degree is over 10 years old. Am I eligible to apply?	The University entry criteria requires applicants to have completed their APAC accredited 4-year sequence within the last 10 years.
	Exemptions to the 10-year rule may be considered for currently registered psychologists who can demonstrate current compliance with the Psychology Board of Australia continuing professional development requirements.
How will I be contacted about my application?	Communication regarding all aspects of the application is via the email address supplied with the UAC application.
	It is the applicant's responsibility to ensure they provide a current email address, regularly check their inbox (including the junk and clutter folders) and respond to any emails they may receive requesting further information as soon as possible.
Can I apply if my Weighted Average Mark (WAM) < 75?	Applicants with a Weighted Average Mark (WAM) of below 75 for their 4 th year of studies will be removed from the applicant pool.
	Applicants in this situation are encouraged to explore opportunities at alternative universities, or to consider reattempting the fourth year to achieve a higher grade. However, it is important to note that this latter commitment involves duplicating prior studies and might not guarantee a higher grade or entry into a master's course – either at Charles Sturt or elsewhere.

 No. Applications to Charles Strut Master of Clinical Psychology and Master of Professional Psychology do not require applicants to supply a personal statement. A CV is an essential part of the application process as it provides a comprehensive overview of an applicant's academic background, professional experience, skills, and achievements. For psychology postgraduate programs, this document, while not included in the eligibility criteria, allows the selection committee to assess an applicant's relevant experience, such as internships, employment in the field, volunteer work, research activities, or other professional development opportunities.

This information complements academic transcripts and other application materials.
Applicants who have not completed a four-year bachelor degree, or equivalent, within the last three years will be required to demonstrate how they have maintained up-to-date knowledge and skills in the area of Psychology since completion of their four-year bachelor degree, or equivalent.
Where an applicant has completed their psychology studies overseas, we will require evidence that their overseas qualifications have been assessed by the Australian Psychological Society (APS), and these studies have been recognised as equivalent to at least a four-year accredited degree in psychology.

With this evidence, an application will be considered, subject to meeting all other admission criteria and all relevant supporting documents being supplied.
Note that the APS will only assess qualifications that have been <i>completed</i> .
Selection procedures will include consideration of:
1. the applicant's academic record;
2. referee reports from at least three referees;
The exact time frame for when invitations will be sent varies depending on the specific program and the volume of applications received. We do, however, aim to begin extending invitations for interviews after the application closing date of 31st October each year.
Interviews have, historically, been conducted on line via Zoom by a panel comprising at least two members of academic staff of the School of Psychology.
The interview is designed to help us explore your reasons for applying for entry to the program, as well as your understanding of psychology as a profession.
To ensure that no one applicant is advantaged over another, no additional information is provided regarding the questions to be asked during the interview.

You will be notified of your outcome after the School of Psychology has completed all interviews and a decision has been made on your application. Unfortunately, we are unable to provide feedback for individual interviews.
Applicants invited for interview will be ranked for offer based overall suitability for clinical training which takes into account academic marks, referee reports, and interview performance.
Not all eligible applicants can be accommodated within the limited number of places available.
First-round offers for the program are expected to be made toward the end of November or the beginning of December. Applicants who receive offers during this time are encouraged to accept promptly to secure their place in the program.
It is important to note that the offer process is ongoing and typically continues beyond the first round. Additional rounds of offers are commonly made throughout December, up until the Christmas break, and often into January.
If you have not received an offer or an outcome of your application, please do not worry—this means your application is still being reviewed.
No, offers cannot be deferred.
If you receive an offer and are unable to commence, please decline as soon as possible so the offer can be issued to another applicant. You are welcome to re-apply for the next available intake where you will compete against a new applicant cohort.
No, the course schedule is fixed and requires commencement during Semester 1. There are no exceptions to this.

Successful applicants will be given a firm date by which to accept an offer of a place. This is usually 7 days.
Offers not accepted by that date will lapse, and we will issue an offer to the next most suitable candidate.

You are required to arrange for a total of three references. These must be submitted by individuals who can provide a professional or academic reference.
 Academic referees: For example, lecturers, supervisors, or tutors who have directly worked with you in an academic setting and can comment on your academic performance, skills, and suitability for the program. Professional referees: For example, employers, supervisors, or colleagues who have known you in a professional or work-related context (does not need to be psychology based) and can provide

	insight into your professional capabilities, work ethic, and relevant experience.

Can I get credit / RPL	Credit allocation in accredited postgraduate psychology programs is strictly governed by the Australian Psychological Accreditation Council (APAC).
	Individuals may be eligible to apply for academic credit if they have completed equivalent coursework subjects in an APAC-accredited postgraduate qualification in another field of professional psychology within the past ten (10) years.
	Credit for prior learning will only be considered for equivalent subjects and will be assessed upon acceptance into the program; credit evaluations cannot be conducted before the official offer stage.
	Credit will not be considered for work experience, research completed in non APAC accredited degrees (including PhD's), or coursework completed in an undergraduates of 4 th year psychology course.
	Individual subjects completed within an APAC-accredited postgraduate (fifth/sixth) year professional psychology degree will be need to be assessed for equivalency to those offered in the Charles Sturt Master of Clinical Psychology for the year of commencement.

Class, Intensives, Placements	
Are classes on campus or online?	All classes for this program are delivered online, providing you with the flexibility to study at a time of your convenience without the need for in-person attendance. The only exception to this is the placement component, which requires you to attend in person
Intensive Schools	attend in person. Some units in this course require mandatory online intensive schools as part of the program. These intensive sessions are designed to provide you with in- depth learning experiences and opportunities for interaction with instructors and peers.

When do I apply to AHPRA? (if applicable)	All students are required to be provisionally or generally registered as a psychologist with the Australian Health Practitioner Regulation Agency (AHPRA) on commencement and for the duration of the course.
	Those without provisional or full registration at the time of accepting an offer, need to apply for provisional registration before you start your coursework.
	Failure to secure / hold registration may see your enrolment with Charles Sturt cancelled.
	In line with AHPRA requirements, Charles Sturt will send a list containing the names of all students commencing or continuing in a course requiring registration directly to AHPRA at the beginning of each calendar year. You will, therefore, not require an individual letter confirming enrolment.
Can I still manage some casual or part time work while studying?	From past experience, we know that balancing the demands of postgraduate psychology study alongside work commitments can be challenging. We strongly encourage you to carefully consider your time and workload before deciding whether to study part-time or full-time.
	It is important to note that your choice of study load—whether part-time or full- time—will not impact your eligibility for an interview or the selection process for offers. Both options are available and you will be assessed based on your qualifications and application materials, not your chosen study load.
Can I go on holiday during my studies?	While the coursework subjects associated with the Masters level postgraduate programs run over the academic semester schedule, placements and the research components may run across the calendar year.
