4. FIRST-AID MEASURES

Inhalation

If inhaled, remove affected person from contaminated area. Keep at rest until recovered. If symptoms develop and/or persist seek medical attention.

Ingestion

Do not induce vomiting. Wash out mouth thoroughly with water. Seek medical attention.

Skin

Wash affected area thoroughly with soap and water. If symptoms develop seek medical attention.

Eve contact

If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses. Continue flushing for several minutes until all contaminants are washed out completely. If symptoms develop and/or persist seek medical attention.

First Aid Facilities

Eye wash and normal washroom facilities.

5. FIRE-FIGHTING MEASURES

Precautions in connection with Fire

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers.

6. ACCIDENTAL RELEASE MEASURES

To manage accidental release, increase ventilation and evacuate all unprotected personnel. Ensure the use of sufficient respiratory protection and full protective clothing. Sweep up the material carefully to avoid dust generation, or dampen it with water to prevent airborne particles. Transfer the collected material into a suitable container, then wash the spill area thoroughly with soap and water. Seal all waste in labelled containers for recycling or disposal, and follow local and national regulations for waste management. If the release contaminates sewers or waterways, notify the appropriate local water and waste management authorities.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of dust, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of dust in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight and moisture. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

Storage Temperatures

Store above freezing and below 93.3°C.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational exposure limit values

No exposure standards have been established for the mixture. However, over-exposure to some chemicals may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions and should be kept to the least possible levels.

Biological Limit Values

No biological limit available.

Appropriate Engineering Controls

Use with good general ventilation. If dust is produced, local exhaust ventilation should be used.

Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable dust/ particulate filter should be used. Refer to relevant regulations for further information concerning respiratory protective requirements.

Reference should be made to Australian Standards AS/NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.

Eye Protection

Safety glasses with side shields, chemical goggles or full-face shield as appropriate should be used. Final choice of appropriate eye/ face protection will vary according to individual circumstances. Eye protection devices should conform to relevant regulations.

Eye protection should conform with Australian/New Zealand Standard AS/NZS 1337 (series) - Eye Protectors for Industrial Applications.

Hand Protection

Wear gloves of impervious material such as rubber gloves. Final choice of appropriate gloves will vary according to individual circumstances. i.e. methods of handling or according to risk assessments undertaken. Occupational protective gloves should conform to relevant regulations.

Reference should be made to AS/NZS 2161.1: Occupational protective gloves - Selection, use and maintenance.

Body Protection

Suitable protective workwear, e.g. cotton overalls buttoned at neck and wrist is recommended. Chemical resistant apron is recommended where large quantities are handled.
