## Background

#### **Purpose**

The Education Strategy Vision is a plan for learning and teaching at Charles Sturt University.

It clearly signals our learning and teaching priorities, informs our academic operations, and guides future learning and teaching decisions. It supports the Education Strategy and its key objectives to provide:

- · sector-leading course profiles
- · leading-edge learning experiences
- · excellence in teaching and graduate outcomes
- · supportive student pathways for aspiration, equity and diversity.

#### Our context and aspirations

The higher education sector is changing rapidly, with the COVID-19 pandemic over the past few years accelerating trends evident in our environment. These include a shift towards more flexible study arrangements and an increasing diversity of qualifications and awards, including micro-credentials and undergraduate certificates. The 'traditional model' of undergraduate study - three years of full-time. post-secondary education - is fragmenting, particularly for regional universities such as Charles Sturt.

With our roots firmly in regional Australia, we have always aspired to help people transform their lives, especially those who are dealing with disadvantage. We provide access, support and educational pathways that transform students into graduates who succeed, lead, change and contribute to their communities. We are committed to our students throughout their whole career journey, to help them build foundational knowledge and skills, upskill, reskill, or reimagine the work they do - and through this, the lives they lead. This transformation is evident as we remain a national leader for graduate employment outcomes. We are in, and of, our communities. We are invested in their success and their ability to thrive into the future.

Our University Strategy 2030 envisions Charles Sturt as the leading regional university in Australia, representing and empowering our communities. To achieve this vision, we need to be innovative in how we radically reimagine the way we deliver learning and teaching to address the needs of modern regional Australia. Setting the vision for the Education Strategy 2030 will guide us toward this goal over the next six years.

The Education Strategy Vision 2030 is the culmination of design thinking methodology that has led to the development of three overarching themes:

- Empower communities
- Inspire students
- · Be exceptional.

These overarching themes have been iteratively built by our staff and are grounded in the reason for our existence as an institution. what we will do to achieve our vision and how we plan to do it. Following three visioning workshops, 10 signature themes emerged as the priorities that will deliver education for modern regional Australia in 2030.

The aspirational signature themes capture the uniqueness of Charles Sturt:

- · our proud regional identity
- · consistently being number one for employment outcomes across the country
- · our commitment to equity of access to education for all.

The signature themes have been mapped at a high level across the other key strategies and projects for Charles Sturt. The Education Strategy Vision has been validated with key stakeholders and the broader academic community.

Building career journeys through experiences	Work-integrated learning is integral to the way we teach, the kind of courses we offer and the types of students we attract. We use experiential learning and embed authentic work-integrated experiences in our courses to provide students with the skills, attitudes and professional networks for meaningful lives and successful careers.
Educating for modern regional Australia	Informed by our research, Charles Sturt leads the identification of emerging regional issues, creates sustainable systems, provides needed graduates, and promotes excellence and equity. We will deliver a growth strategy that responds to regional Australia's opportunities and needs. Our drive for regional outcomes will have global impact.
Partnering for real regional solutions	We connect with our regional communities to identify challenges that need to be solved, such as changing climates, resource scarcity and healthy populations. We will continue to share our infrastructure and other assets, and empower our thought leaders to meaningfully collaborate with our communities to research, develop and deliver solutions. From renewable energy hubs and decarbonised regional industries to forward-thinking regional health solutions, internet connectivity and access for all. Partnerships will align with our courses and student learning aspirations and we will be active in our regional areas.

We meet them wherever they are in terms of their career journey, location and life, connecting them with the options they need – from pathways, credit, accelerated degrees, short-form learning, flexibility and more. We provide a supportive and culturally safe place to learn that supports their progression, and students will return to us as their preferred education provider over the course of their career, building a partnership for lifelong learning.
